In Ukraine, it will be safer to travel by bus. The Government approved amendments to the Resolution No.1081 prepared jointly with BRDO experts and designed to liberalize the market of interregional bus services and make it official. As a result, a share of legal interregional bus services will increase, the quality of services will be improved in a competitive market and tariffs will decrease to economically justified ones.

With the aim of providing Ukrainian schools with leading technologies, the Ministry of Education together with the BRDO Office developed a draft regulation on electronic textbooks. The new regulation will increase quality standards for educational content producers, reduce administrative barriers to enter the market as well as increase the transparency in the use of budget funds, and most importantly – it will be much more interesting for children to study, and the burden on their shoulders will lighten.

The first admission appeared to be in great request: four people for one seat. 35 young civil servants from 10 ministries, the AMCU, the NKREKP, the Agency for E-Government and the VRU started to study the art of drafting regulatory acts.

In Lviv, the BRDO Office and the Lviv City Council signed a [Memorandum on cooperation](#) during the presentation of the Concept for development of the market of electric charging stations by 2030. Lviv was chosen for a good reason, because it is the most progressive city in the development of electric vehicles while being the first Ukrainian city where the concept for the development of charging stations infrastructure for electric vehicles was adopted.
