



#### **DECISIONS FOR BUSINESSES**

Long-awaited amendments to the resolution of the Cabinet of Ministers 1548 on deregulation in pricing were published. From now on, the regulation of prices and tariffs for the following services are cancelled:





the execution of land surveying works in case of free transfer of land plots to citizens of Ukraine in accordance with the legislation;

services related to electronic digital signatures. Read more *here*.

Connection to electrical networks is one of the main obstacles to the development of Ukrainian business and a negative factor that discourages international investors to invest in the country. A new method to determine the non-standard connection cost developed with the participation of BRDO experts should improve this situation. Read more *here*.

The Government adopted risk assessment criteria to establish state price regulation by the State Food Safety Service. Read more *here*.



### **INSPECTION REFORM**

The BRDO Office started transferring the Inspection portal to the State Regulatory Service. The Inspection portal is a full-fledged independent tool of the system of state supervision and control measures. Currently, 27 of 33 inspection bodies have joined the work and published information about their inspections on the Inspection Portal inspections.gov.ua. Details *here*.



## **BRDO INITIATIVES**

A key issue for Ukrainian business and international investors is raider attacks. Since 2014, more than 1,700 raider attacks have been recorded, and there were more than 500 such cases only in Kyiv and the region. A draft law No.9311 #RaidingStop developed by the Ministry of Justice together with the BRDO, ACC, EBA, SUP and the Business Ombudsman Office can improve the situation. Read more *here*.

Every year, 800 thousand individuals and legal entities register 1 million state-owned and municipal land plots in Ukraine. However, the legislation was developed in such a way that it is almost impossible to register a land plot without violations, and this procedure is corrupt, cumbersome, non-transparent and long-lasting. The government, business, public and expert community representatives discussed these issues and other problems in this area during the Roundtable "Land development and allocation for new construction projects.

The BRDO Office together with the government, business, public and expert community representatives discussed e-commerce problems at the roundtable "E-commerce: Smart Regulation for a Progressive Market". Key BRDO's proposals were prepared based on the Green Paper "E-commerce Market". Read more here.
