Draft law on planned use of territories signed by the President

Draft law #2280 was signed by the President on July 23. It provides much needed legislative basis for amalgamated communities in Ukraine to develop complex spatial planning documentation for their areas. The Law provides a legal mechanism for landowners both in urban and rural areas to choose the target purpose of their plots and simply notify cadaster registry officials without the need to gather a set of paper documents. BRDO experts actively participated in the development of the law and welcome the approval of this initiative!

Draft law on quality of construction products is ready for the Second Reading in the Parliament

The Parliament Committee of Local Governance, Regional Development and Urban Planning supported the draft law #2698, developed with the participation of BRDO experts. The proposed draft law implements the Regulation (EU) No 305/2011 into Ukrainian legislation and sets requirements for buildings throughout their lifecycle (such as construction strength or fire and ecological safety). We call for members of the Parliament to support the law in the Second Reading!

Could Ukrainians buy apartments without real estate agents? BRDO experts analyzed the draft law «On Realtor Activity in Ukraine»

The draft law #3618 is aimed at protecting citizens from compulsory realtor services. Unfortunately, the draft is not based on a profound analysis of problems it is aimed to solve and hence, it must be thoroughly improved. In reality, the provisions of the draft law in effect actually reduce not enhance the consumers' options during the realization of contractual transactions during rental or purchase of secondary market apartments. BRDO proposes to properly scrutinize the key provisions by conducting a proper Rolling Review in conjunction with Round Table debates in order to enhance and amend questionable sections of the proposed draft law. Single State E-system in Construction has been launched

The e-portal is now available for users. It is based on the law drafted with contributions from the BRDO experts The Portal will be available in a test mode until the end of November 2020, and from December 1 the system should be fully operational. E-system provides digitization of paper documents, helps to minimize corruption risks, increases quality of provided services, and simultaneously substantially decreases time to provide numerous services.

Will Regulatory 'guillotine' work in Ukraine?

Better regulation and effective legislative update could be achieved in several ways. One of the instruments is regulatory 'guillotine' when ineffective or obsolete regulatory norms are just canceled. Another instrument is rolling review which consists of an analysis of a specific market or sphere and its regulatory procedures, rules for business, while examining their overall transparency and simplicity. BRDO experts have been working with Ukrainian legislation for many years, and our scrupulous work have shown that deep analysis of processes within the specific sector is more comprehensive than just automatic cancellation of ineffective or obsolete laws and regulations. BRDO CEO Oleksii Dorogan explains why regulatory 'guillotine' will not bring expected results in Ukraine.



Moratorium or no Moratorium on inspections during lockdown – which one is it?

During the coronavirus lockdown Ukraine has passed moratorium on state inspections of business. However, several spheres and types of inspections are not included in the moratorium. For instance, among them there are the inspections of fire or ecological safety, working conditions, spheres of customs and currency control, market surveillance, as well as protection of economic competition. 
