### **DECISIONS APPROVED AT THE CMU DEREGULATION SESSION**

During the Cabinet of Ministers of Ukraine deregulation meetings, a series of important BRDO initiatives was approved to ease doing business and improve public administration in Ukraine.

#### NATIONAL REGISTER FOR THE ORGANIC MARKET

A domestic register of organic goods producers certified to Ukrainian standards will be introduced for the first time since Ukraine's independence. From now on, only producers included in the specified registers will have the right to mark their products with the Ukrainian "organic" logo. In that way, every customer can check a product labelled "organic" by using a special code in the open register and see whether its production meets the designated standards. Read more

#### IMPROVED SYSTEM OF REMOTE CONTROL OF FISHING VESSELS

This initiative would oblige fishing vessels owners to install GPS sensors for the specialized agencies to monitor the vessels' movement through water areas. This will protect responsible fishermen suffering from unfair competition from poachers hiding the amount of fish caught due to the lack of control over the movement of fishing vessels. The initiative will also help to identify violations like illegal fishing. Read more

#### INCREASED FEES FOR THE SPECIAL USE OF AQUATIC BIORESOURCES

Considering the 10-year inflation rate, BRDO suggested increasing the fee by 3.4 times. The accumulated resources could boost the development and restoration of the fishing industry and aquaculture. Read more

#### NEW RULES OF PROCEDURE AND RBM FOR THE CABINET OF MINISTERS

On February 29 the Cabinet of Ministers approved new Rules of Procedure developed with contributions from BRDO experts. The document is based on the new approaches for strategic planning, stakeholders' engagement, impact analysis, and state policy effectiveness evaluation. Based on the adopted RoP, the RBM system for policymaking process being developed by BRDO experts is to be applied by the SKMU. Read more

#### BRDO PRESENTED ITS VISION ON THE DEVELOPMENT AND TRANSFORMATION OF THE COAL INDUSTRY IN UKRAINE

BRDO experts conducted a systematic analysis of the coal industry under which the current regulation does not create the necessary environment for the industry's development. Moreover, one in five of 88 industry-specific legal acts is illegal or irrelevant. The problems of the industry and possible solutions were presented during the round table on January 30. Read more

### THEDRAFTLAW, DEVELOPED BY IT&TELECOM SECTOR, REGISTERED IN PARLIAMENT

The registered draft law #3014 developed by BRDO lays the groundwork for the comprehensive reform in the telecom sector. It stipulates protection of consumers rights through a bunch of instruments like email subscription opt-out, provides transparent rules for telecom operators, and ensures integration with the EU's legislation and digital single market.
