CONSTRUCTION OF BOMB SHELTERS – DRAFT LAW NO. 7398 WAS ADOPTED AS A WHOLE

Ukrainian Parliament adopted in the second reading the draft law #7398, developed jointly with the BRDO team. This document will create conditions for the construction of civil defense facilities and dual-purpose facilities in accordance with the level of threats arising from the full-scale aggression of the Russian Federation. From now on, new buildings with significant (CC3) and medium (CC2) classes of consequences, in which more than 50 people are permanently present or more than 100 people are periodically present, as well as other construction objects according to the list determined by the Cabinet of Ministers of Ukraine, must have protective structures of civil protection (bomb and anti-radiation shelter) or dual-purpose structures. NEW COALITION RISE UKRAINE WILL WORK FOR TO ENSURE UKRAINE'S RECONSTRUCTION WILL BE DONE WITH INTEGRITY, SUSTAINABILITY, AND EFFICIENCY

During the conference in Lugano a panel discussion **“Efficient Reconstruction: Anti-corruption and Transparency Initiatives”** dedicated to the role of civil society in ensuring transparency and accountability of the recovery process of Ukraine took place. It was announced then that a new coalition of Ukrainian organizations and international partners — **RISE Ukraine** — has been launched at the Lugano Ukraine Recovery Conference to promote a vision of integrity, sustainability and efficiency for the country's reconstruction. Better Regulation Delivery Office is among the members of the coalition. The coalition, which unites more than 20 Ukrainian organizations working on open government and anticorruption reform, has unveiled 10 principles for Ukraine's reconstruction and modernization. IN UKRAINE, THE E-SYSTEM OF MANAGING FINANCIAL COMPENSATION FOR CITIZENS WHO ARE READY TO SHELTER IDPS WILL BECOME OPERATIONAL

Russia's war against Ukraine continues. Thousands of people are urgently evacuated to safer regions. Most of them do not have a place to wait out difficult times. To solve this problem, Ukraine financially supports citizens who are ready to shelter internally displaced persons. A separate state electronic management system is being developed for the convenience of providing compensation for the hosting of IDPs. The system functions with the aim of automating (optimizing) and digitizing the processes of collection, verification, integration of information data from resources, saving information, accounting and forming the data necessary to compensate the persons who accommodated internally displaced persons for the costs associated with free temporary accommodation of IDPs. The electronic system is being developed as part of the **Innovation Laboratory for EU project**, implemented by the federal company Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH on behalf of the German Government. The Ministry of Regions and the Ministry of Digital Transformation of Ukraine are working on the implementation of the project with the participation of BRDO. Digitization of the new admin service takes place, in particular, through its integration with the [Shelter](#) service.

WHAT LESSONS SHOULD UKRAINE LEARN FROM THE WAR? SPECIAL PROJECT OF NAPC

The National Agency for the Prevention of Corruption makes publications within the framework of the project "Ukraine Now. A vision of the future". At its core is a broad public dialogue about the lessons society should learn from the war. The hero of a new interview within the framework of the project is Roman Kobets, an expert in the development of state policy at BRDO. "The uniqueness of the moment is that we are experiencing what is called an existential crisis in an individual sense, when our very existence is brought into question. This is a moment that makes people look at themselves with different eyes. This process is not fast, but it gives an opportunity to shift those things that have remained unchanged for many years, to which no one even paid attention." HOW WILL UKRAINE COPE WITH THE NEXT HEATING SEASON?

Russian gas blackmail has achieved its goal — some easing of sanctions. Canada and Germany made concessions to the Russian Federation by easing the sanctions regime in order to save the heating season in Europe. On July 17, Canada sent one of the repaired gas turbines to Germany, which could not be exported and serviced at the German Siemens Energy plants located on its territory due to sanctions. It was the impossibility of obtaining a turbine that Moscow explained the radical reduction of gas supplies to Germany. The Western powers that conceded to the Russian Federation are sure that the ban on the repair and return of the gas turbine was only used as an excuse by the aggressor country. APPEALS TO INTERNATIONAL ORGANISATIONS AND COMPANIES

BRDO supports the global movement of appeals to international organisations, corporations, and separate companies to exclude the RF from respectable international organisations and to boycott the aggressor by stopping business operations with it. In July, BRDO experts appealed to **Veolia Environnement S.A.**, which on the 141st day of the full-scale war of the Russian Federation against Ukraine continues to provide services to the terrorist country, as well as to Invest Hong Kong, the state agency for foreign **investments of Hong Kong**, which entrusted the Moscow office with contacts with Ukraine.
