THE INTERDEPARTMENTAL WORKING GROUP ON THE ISSUES OF ACCELERATED REVIEW OF STATE REGULATORY INSTRUMENTS HAS STARTED ITS WORK

Green light for deregulation! The Interdepartmental Working Group on Issues of Accelerated Review of Instruments of State Regulation of Economic Activity (IWG on Deregulation) has started. BRDO prepares analytics on the necessity of maintaining or cancelling regulations, the priority of digitization of state regulatory tools, participates in meetings, and helps to implement the decisions of the IWG, in particular, to develop legal acts. The goal of the IWG on deregulation is to improve the business climate in Ukraine. Currently, more than 1000 instruments have been identified in the state regulation of economic activities, including: 528 permits, 224 licenses, 157 approvals, 145 conclusions, 121 certificates, 55 declarations, 42 notifications, 23 certifications. Accordingly, with such a large number of regulatory tools, it is quite difficult to start and run a business. OPEN STATEMENT OF THE RISE UKRAINE COALITION ON ENSURING THE AVAILABILITY OF OPEN DATA

RISE Ukraine Coalition was founded to support the recovery and modernization of Ukraine after the war. We also work to increase the number of funds allocated for reconstruction and ensure their transparent and effective use. Unfortunately, we have to state that the achievement of this goal is currently under threat. A key element of transparency and accountability is access to public information in the form of open data. After the introduction of martial law, valuable sets of open data on which the infrastructure of transparency and anti-corruption in Ukraine was built for years disappeared from public access. Limitation of access to information occurred chaotically, without proper legal regulation and public discussion. This was justified in the first months of a full-scale invasion but is unacceptable ten months after the invasion began. How the closing of public data endangers the future reconstruction of Ukraine? "TREMBITA" WILL WORK MORE TRANSPARENTLY AND EFFICIENTLY: THE GOVERNMENT HAS ADOPTED A REVOLUTIONARY RESOLUTION

The government adopted a revolutionary document that will improve the functioning of the electronic system "Trembita", with the help of which state registers exchange data among themselves. Normative and legal regulation of issues related to its functioning was not systematic. Separate provisions concerning the functioning of the Trembita system were written in various NPAs. BRDO experts, together with representatives of the Ministry of Digital Transformation and the EU4DigitalUA project, funded by the EU, worked on the creation of a complete legislative package, which regulates all aspects of the functioning of Trembita, as well as bringing the legislation into compliance with the Law of Ukraine "On Public Electronic Registers". From now on, citizens will be able to be notified when someone views their personal data in state registers, because the document forms the legal basis for the creation of a monitoring subsystem that will record the facts of access to citizens' personal data in the framework of electronic interactions. In addition, the procedure for electronic (informational and technical) interaction contained in the Regulation makes contracts on electronic interaction bilateral. Subjects of electronic interaction may also participate in electronic interactions directly or delegate such right to an operator authorized by them.

INFOGRAPHICS: EXPLAINERS OF WHAT TO DO IN DIFFERENT SITUATIONS

BRDO created a cross-sectoral initiative in coordination with state authorities to create infographic instructions with explainers for businesses and citizens on what to do in different situations. In particular, the following instructions were designed (in Ukrainian):

- 1. Connecting the service of National Roaming
- 2. Official accounts of funds for reconstruction due to military aggression of the RF
- 3. European Green Deal and railways: transforming the market of freight transportations of Ukraine into a "green" one
- 4. <u>Statistics of Ukrainian emigration because of the war</u>
- 5. How does Russia circumvent port sanctions and how can it be prevented?
