

### THE CABINET OF MINISTERS ABOLISHED 204 BUSINESS REGULATION INSTRUMENTS

As part of the deregulation reform, the Government of Ukraine has adopted a resolution and an order <u>cancelling 204 state regulatory instruments</u> related to business operations. 52 regulatory acts have been declared invalid: 25 in full and 27 partially. The overall economic effect of the reform is estimated at over UAH 600 million annually, which businesses will now save by no longer needing to go through obsolete and unnecessary procedures.






#### HOW PUBLIC AUTHORITIES PUBLISH AND UPDATE OPEN DATA – BRDO DASHBOARD

BRDO <u>has developed an interactive dashboard</u> that analyses how Ukrainian government authorities comply with the CMU Resolution No. 835 on open data. The tool provides overall statistics, the level of compliance by data holders, and the popularity of specific datasets based on the number of downloads. The most popular dataset by number of downloads is "Information on Vehicles and Their Owners", published by the Ministry of Internal Affairs of Ukraine, with 86,000 downloads.







### APPLICATIONS FOR THE UKRAINIAN ENTERPRISE PROMOTION AWARDS 2025 HAVE STARTED

The <u>selection process</u> for the national UEPA 2025 award, which recognises the best initiatives for entrepreneurship development in Ukraine, has begun. Projects supporting SMEs from all over Ukraine are invited to participate. Applications can be submitted until May 23, 2025.



### AI-POWERED DAILY DIGEST OF CORRUPTION VERDICTS – "CORRUPTION RADAR" CHANNEL

BRDO has launched a Telegram channel called Corruption Radar, which monitors court verdicts in corruption-related cases daily. The channel automatically tracks new court decisions, analyzes them, and publishes a digest with Al-generated summaries for each verdict. The digest includes verdicts classified under Article 45 of the Criminal Code of Ukraine as corruption criminal offenses (Articles 210, 354, 364, 364-1, 365-2, 368–369-2) and offenses related to corruption (Articles 366-2, 366-3).
